

**MINUTES OF THE MEETING
OF BULKELEY AND RIDLEY PARISH COUNCIL
HELD ON TUESDAY 19TH SEPTEMBER 2017**

1. **APOLOGIES**

None received.

2. **DECLARATION OF INTERESTS**

Councillors were invited to declare pecuniary or non-pecuniary interests arising from matters on the agenda.

No declarations were received.

3. **APPROVAL OF THE MINUTES**

Resolved:- That the Council approve the minutes of the Parish Council meeting held 16th May 2017. Proposed by Cllr Weddell on and seconded by Cllr Knight.

4. **MATTERS ARISING FROM THE MINUTES**

There were no matters arising from the minutes.

5. **OPEN FORUM**

There was no consideration of this item as no members of the public were present.

6. **POLICING**

Report from the Police Cluster Meeting:-

Cllr Hastings attended the police cluster meeting on Wednesday 13th July at the Goodwill Hall Faddiley. Seven parishes were represented and a representative from Cheshire East.

The figures relate to the period 1st April - 30th June.

Crime :-

Across the cluster there were 7 burglaries, 7 criminal damage, 0 drug offences, 1 other offence, 11 public order offences, 7 theft/stolen goods, 2 vehicle offences and 6 violence against the person. Two burglaries happened in Bulkeley; a garden shed was broken into and a lawn mower stolen, and a stables was broken into and items of tack removed. At a later date, two people were arrested in Chester and found to have numerous items of tack, so they might have been responsible for this theft.

Road Traffic Accidents:-

There were 6 accidents in our parish; 4 with injury and two damage only. Two of the accidents with injury happened at or near Ridley Green corner and the other two were on the A534 in Ridley and one near the Poacher. The two with no injury happened on the A49 in Ridley.

Anti-Social Behaviour:-

There were no incidences of anti-social behaviour in the parish, but inevitably one at Peckforton Castle where a drunken guest offered to fight everyone.

10. **HIGHWAYS**

10.1 Speedwatch:-

Cllr Hastings updated the meeting regarding the Speedwatch campaign. The Council agreed to purchase hi viz vests.

10.2 A534:-

Councillors considered the problem of overtaking through Bulkeley and agreed to contact Highways regarding the options.

10.3 Footpaths on A534:-

Footpath and Dropped Kerbs:- The Council considered the request received from Mrs Flavell Matts regarding the footpath and dropped kerb problems in Bulkeley. The Council agreed for a representative to meet with Highways after their meeting has taken place with Mrs Flavell Matts. The Council also agreed to contact CEC and request costings and feasibility.

Footpath opposite the Chapel:- the footpath is overgrown. The Council are to contact CEC to establish who owns the land before arrangements to cut the grass are made.

11. **VILLAGE MAINTENANCE**

The Council agreed for Kevin to continue maintaining the village.

12. **COMMUNITY PRIDE COMPETITION**

There was no Community Pride Competition in 2017. The competition is to be relaunched in 2018 as the Best Kept Village. Full details of the new format are to follow.

13. **PLAYING FIELD**

The playing field has been mowed eight times this year. The Council has paid for ten cuts, the remaining two cuts are to be done over the next month.

The Council discussed dog fouling at the playing field and the proposed CEC legislation.

Councillors were encouraged to complete the online survey.

14. **BICKERTON VILLAGE HALL**

Cllr Hastings updated the meeting about the recent events at the hall and the funds raised.

15. **WEBSITE**

Cllr Weddell circulated a paper detailing the objectives of the website and the actions undertaken or required (see attached). The actions required include possible additions such as useful links, local pictures, local history, calendar of events, a detailed boundary map, survey on local issues, contact details advice and a news section.
